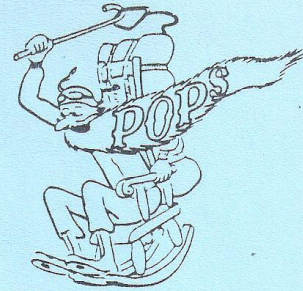

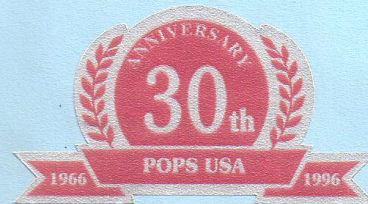

U.S. and world formation skydiving champions "Arizona Airspeed" dropped in on the 43rd Annual PGA Merchandise Show in Orlando, Florida, last month. The team used the 18<sup>th</sup> hole at the Falcon's Fire golf course as the landing area.

The golf expo was the largest of its kind, and it was held in the Orlando County Convention Center with 900 exhibitors and an estimated \$1.3 billion in sales during the four-day run. The crowd was reportedly thrilled by Airspeed's performance, and skydiving got some good press in return.

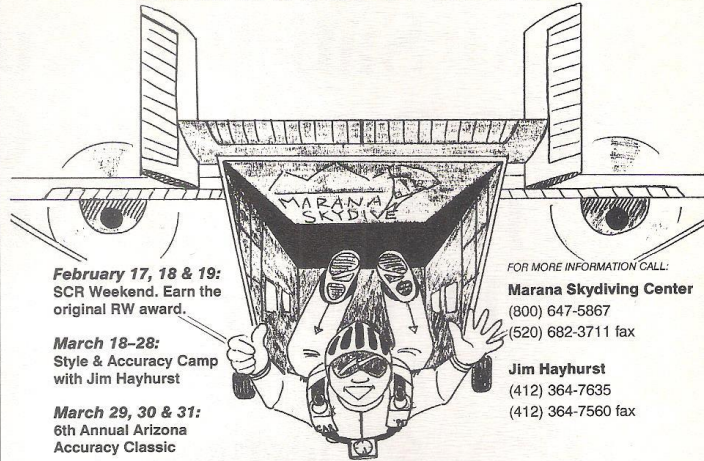

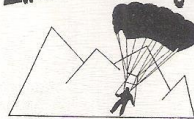
